#### Re: Financial Audit of Local EWP

A mail audit was performed on the financial books for the Local EWP located in Los Angeles, CA in 2010. The audit was coordinated with Sam Samad, Local President and Warren Yoshizuka, Local Treasurer. The following are the findings of the audit.

#### LOCAL CONSTITUTION / BY-LAWS /FINANCE POLICY

Local provided a valid local constitution and bylaws.

#### LOCAL FINANCIAL PROGRAM

Local does not use any financial program. It uses the manual check register.

#### **BANK STATEMENTS**

All bank statements were presented.

#### REBATE CHECK STUBS

All rebate check stubs were presented.

#### **DEPOSIT SLIPS**

Local maintains deposit slips.

#### MEMBERSHIP LIST

Local maintains a list of members and uses the rebate list to verify it is correct each quarter.

#### **CANCELED CHECKS**

Local provided requested copies of canceled checks.

#### **VOUCHERS / RECEIPTS**

Selected vouchers were provided and were in good order. However, it was noted that the vouchers for purchases of food did not include the list of members who participated. This should be recorded with all food purchases.

#### **INVENTORY ASSET LIST**

Local has no inventory other than a broken computer which is being disposed of.

#### **MEETING MINUTES**

I was not able to obtain copies of the minutes prior to completing this report, therefore I cannot determine the condition of the records for this category.

### **FINANCIAL REPORTS**

Local creates an end of year financial reports and adopts a yearly budget.

#### **LOANS**

No loans were made in 2010. Local provides advances to members for travel expenses but it does not become a loan unless voucher is not filed timely.

#### **BONDING**

Bonding is handled through NATCA national. A copy can be obtained from national if needed.

#### LM FORMS

A copy of the LM3 was provided.

#### IRS FORMS / AFFIDAVIT

A copy of the IRS 990N was provided.

#### **NEW MEMBER APPLICATIONS**

Local maintains copies of member applications.

#### OTHER INCOME DOCUMENTATION

#### None

Overall the records appear to be in good condition and there is no need to review any additional records. The Local is encouraged to review the comments made above to further improve their record keeping. The audit took a long time to complete and ultimately I decided to close the audit having reviewed most of the records requested.
